# CHAPTER 7. SYSTEM DESCRIPTION AND OPERATION

# 7-1. System Description




Figure 7-1. Partial Wide Instrument Panel

1. The Partial Wide Instrument Panel (Figure 7-1) accommodates a combination of traditional instruments and a Chelton EFIS system. The configuration provides the dual flight and navigation instrument functions, allows for both traditional instrument and EFIS training, and allows the Enstrom 480B model to retain flexible cabin seating capability.

2. The total instrument complement and location may vary depending upon the specific owner specifications and aircraft options.

3. Instruments, controls, and indicators not shown in Figure 7-1 are shown in the Basic RFM chapter/section which describes their related systems.





Figure 7-2. Instrument Panel Switches

4. The circuit breaker switches located on the lower right side of the instrument panel are shown in detail in Figure 7-2. Primary circuit breakers and optional equipment circuit breakers are located on the center pedestal panel as shown in Figure 7-3.
